
## Navigating

## 4. How to ask a question

**Note:** Only verified Members and Proxyholders are eligible to ask questions.

You will be prompted to enter your member number or proxy details before you can ask a question. To ask a question, click on the **'Ask a Question'** box either at the top or bottom of the webpage.

The 'Ask a Question' box will then pop up with two sections for completion.

## Joining the Meeting via Phone

#### Step 1

From your land line or mobile device, call:

- International: +61 2 9189 8867

## Step 2

You will be greeted with a welcome message and provided instructions on how to participate in the Meeting. Please listen to the instructions carefully.

At the end of the welcome message you will be asked to provide your **PIN** by the moderator. This will verify you as a Member and allow you to ask a question at the Meeting.

#### Step 3

Once the moderator has verified your details you will be placed into a waiting room and will hear music playing.

Note: If your membership cannot be verified by the moderator, you will attend the Meeting as a visitor and will not be able to ask a question.

#### Step 4

At the commencement of the Meeting, you will be admitted to the Meeting where you will be able to listen to proceedings.

## **Asking a Question**

#### Step 1

When the Chairman calls for questions or comments on each item of business **press \*1** on your keypad for the item of business that your question relates to.

If at any time you no longer wish to ask a question or make a comment you can lower your hand by **pressing \*2** on your keypad.

#### Step 2

When it is your time to ask your question or make a comment, the moderator will introduce you to the meeting, your line will be unmuted and you will be prompted to speak.

If you have also joined the Meeting online, please mute your laptop, desktop, tablet or mobile device before you speak to avoid technical difficulties for you and other members.

#### Step 3

Your line will be muted once your question has been answered.
