"I believe there should be Aboriginal people at the highest places in the Australian economy, having Aboriginal people involved in the decision making of organisations, and I'm very pleased to be taking a seat at the AICD National board table.

"As a governance organisation committed to lifting the level of Aboriginal participation, I see this as an opportunity to achieve a greater understanding and appreciation of what Aboriginal people can contribute to Australia's social and economic landscape."

AICD chair John Atkin FAICD congratulated Mr Hamm and said his appointment would enrich the work of the Institute with his expertise, specialist skills and insights.
