"That's why the AICD is so pleased to offer this scholarship and to play its part in helping equip directors, boards and their organisations to deal with the increasingly complex operating environment."

Former scholarship recipient and Centre for Stories director, Charlotte Solomon, said the scholarship is an opportunity to meet other emerging and career directors, and learn governance skills in a not-for-profit context.
