# Staying on target

Towards gender parity on boards

Five years ago, the AICD and the 30% Club set a target for all S&P/ASX 200 companies to have at least 30 per cent women on their boards by the end of 2018.

We reached this target at the end of 2019 and I am pleased to report that the momentum continues. As at the end of July 2020 female directors now represent 31.3 per cent of the ASX 200.

Each quarter for the past five years, the AICD has published the names of companies who have reached the 30 per cent target, encouraging others to emulate their efforts. Our reports have also identified companies who are lagging. In September 2015, we named 30 companies in the ASX 200 who had no women on their boards. At the time of printing this report, there is now only one board in the ASX 200 with no women.

This is a significant achievement and is, we believe, testament to the value in regularly reporting progress. Combined with a range of initiatives focused on promoting the pool of female board-ready women, we believe that setting this voluntary target has been a powerful agent of change.

It is also encouraging to see that the ASX 300 is close to meeting the target with 29.3 per cent female directors. While more work needs to be done to increase the diversity of smaller listed company boards we are heading in the right direction. Despite these positive shifts, nearly half the companies on the ASX 200 have yet to reach the 30 per cent target. At an individual board level, 30 per cent is significant. The true value of diversity is recognised not through representation alone, but when that representation translates to contributions that are heard and valued.

# 30% Club update

## A focus on the ASX 300



Nicola Wakefield Evans FAICD Chair, 30% Club Australian Chapter Non-Executive Director This quarter we are pleased to report that women now comprise 31.3 per cent of directorships on ASX 200 boards.

Companies at the top of the ASX continue to lead the charge, with more than half of the ASX 100 now at more than 30 per cent women on their boards, and 28 boards comprised of more than 40 per cent women.

At the same time, while a quarter of businesses in the ASX 201-300 category have achieved the 30 per cent level of female board membership, more than half have only one woman or none at all. Companies in the top 100 see diversity as a business imperative, enabling long-term financial and non-financial benefits by recruiting from the broadest talent pool, challenging group think and improving governance and risk management.

The 30% Club will continue advocating for a voluntary target of 30 per cent female directors on all ASX boards by the end of 2021, in line with best practice guidelines set out in the ASX Corporate Governance Principles and Recommendations. Last month KPMG and the 30% Club released a report Building gender diversity on ASX 300 boards: Seven learnings from the ASX 200 on how to build greater gender diversity on boards. It delved into data of the ASX300 and presented key insights from non-executive directors on ways in which the mid-tier sector could improve their approach to diversity.

The report notes that ASX 201-300 companies are more likely to be family-owned enterprises and often board representation is not something that is given detailed consideration until the point at which they make the decision to list on the ASX. It is often under these circumstances that the myth of a shortage of qualified, boardready women is perpetuated.

The reluctance to embrace the opportunities of boardroom diversity indicates a lack of understanding by mid cap firms about the market and performance value of including women in their leadership ranks. In addition to proven financial benefits<sup>1</sup>, there is an increasing expectation from institutional investors, customers and employees for a demonstrated commitment to board diversity by companies. Boards would be wise not to ignore this shifting sentiment.

Making diversity a consideration from the earliest stages of a company's formation will ensure that representation is not a boxticking afterthought. The approach to diversity should be both intentional and strategic and part of business strategy for diversity to lead to enriched outcomes.

There is no shortage of qualified, board-ready women in Australia. We look forward to continuing our work with stakeholders toward achieving gender parity on boards and addressing systemic barriers to this change.





## Progress Report (ASX 300)

The 30% Club is tracking the progress of S&P/ASX 300 (ASX 300) companies in reaching the 30 per cent target by the end of 2021.

For the purposes of tracking progress, we looked at the statistics of:

- Those companies in the ASX 300; and
- ii. Those companies that feature in the ASX 300 but not in the S&P/ ASX 200 (ASX 200).

#### Methodology

The constituents of the ASX 200 and 300 are based on the June 2020 Quarterly Rebalance of the S&P/ASX Indices.

For the purposes of our analysis of the statistics of ASX 300 companies, we have removed the companies that feature in both the ASX 200 and ASX 300 indexes, so our focus is on the companies that only feature in the ASX 300.

#### **Statistics**

The overall percentage of female directors on the boards of the companies currently in the ASX 300 index is 29.3 per cent.

The percentage of female directors on the boards of ASX 201-300 companies remains at only 23.7 per cent.

The percentage difference highlights that ASX 200 companies, particularly those ranked in the top 100, are lifting the overall percentage of both the ASX 200 and ASX 300 indexes. The rankings and companies in the table below are from the ASX 300 only and do not sit within the ASX200. Individual chairs with an asterisk next to their name are members of the 30% Club. They are committed to ensuring a minimum representation of 30 per cent female directors on their boards.
